## IMPORTANT SAFETY INFORMATION

### Does the EPIOXA™ corneal collagen cross-linking procedure have any side effects?

The most common side effects were red eye, haze, sensitivity to light, disruption of surface cells of the cornea, eye pain, eye irritation, watery eyes, swelling of eyelid, fine white lines in the cornea, reduced sharpness of vision, dry eye, and eye inflammation.

### The EPIOXA™ corneal collagen cross-linking procedure should not be performed if:

- You have a known hypersensitivity to any ingredients in the product.
- You had cataract surgery and either did not receive an artificial lens in your eye or received a non-UV blocking artificial lens.
- You have a history of herpetic keratitis.
- You are pregnant.

### What is the EPIOXA™ corneal collagen cross-linking procedure?

The EPIOXA corneal collagen cross-linking procedure is performed by your eye doctor for the treatment of keratoconus. It does not require the removal of the corneal epithelium (outermost layer of the front of the eye). It consists of EPIOXA™ HD (riboflavin 5'-phosphate ophthalmic solution) 0.239% and EPIOXA™ (riboflavin 5'-phosphate ophthalmic solution) 0.177%, which are prescription eye drops used in combination with the O<sup>2</sup>n™ System and Boost Goggles®.

### Who can have the EPIOXA™ corneal collagen cross-linking procedure?

The EPIOXA corneal collagen cross-linking procedure is for the treatment of keratoconus in adults and pediatric patients 13 years of age and older.



## What is EpioxaCareConnect™



EpioxaCareConnect™ (ECC) is a free patient program that guides you through your Epioxa™ cross-linking (CXL) treatment journey. A team of caring experts are there every step of the way—from checking insurance coverage to navigating financial assistance and/or co-pay support for those who qualify.

### Your program includes:



#### Coverage and Benefits Review:

You'll receive help understanding your insurance coverage and any steps required before treatment.



**Treatment Navigation:** You'll get clear guidance through your Epioxa™ CXL treatment journey, so you know what to expect at each stage.



**Financial Support Guidance:** You'll learn whether you qualify for financial assistance programs that may lower your out-of-pocket costs.



## Meet Your Patient Access Liaison (PAL)

Once you're enrolled in EpioxaCareConnect™, a Patient Access Liaison (PAL) is your dedicated point of contact who can provide one-on-one non-medical support to help you feel informed, prepared, and supported during your treatment journey with Epioxa™.

### Your PAL can\*:

## What to Expect

The EpioxaCareConnect™ program is designed to make getting started simple and transparent.

### Here's how it works:

**Enrollment:** If you and your doctor decide Epioxa™ cross-linking treatment is right for you, your doctor's office may enroll you in EpioxaCareConnect™.



**Your EpioxaCareConnect™ team will reach out** to you upon completed enrollment.

**Benefit Review:** Once enrolled, EpioxaCareConnect™ will check your insurance benefits and confirm your coverage for the treatment and whether you may qualify for any financial support.



**Your PAL will review your coverage** with you and explain what it means for cross-linking treatment. They can also help identify co-pay or financial assistance options to lower out-of-pocket costs.

**Authorization Support:** Your doctor's office will work together with your insurance plan to request approval.



**Your PAL will stay in touch with you**, provide updates, and answer questions on insurance process or additional information needed.

**Scheduling & Treatment:** Once your treatment is approved, your doctor's office will schedule your cross-linking procedure and guide you on the next steps.



**Your PAL will help to coordinate** your treatment logistics and provide educational resources.
